Chasen Logistics Sdn Bhd	To relocate 14 production lines for a solar panel manufacturer in Malacca, Malaysia with an estimated contract value of RM3 million to be completed by December 2011  Status upgraded to an in-house relocation contractor for an MNC semiconductor manufacturing company in Ipoh, (Perak), Malaysia
Chasen Logistics Services Limited	Turnkey contract to relocate semi-conductor production lines from Singapore, Malaysia to Czech Republic, Eastern Europe. This project has an estimated contract value of SGD1,200,000 and will be completed by August 2010
