The Board of Directors (the “**Board**”) of Chasen Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) is pleased to announce that the Company’ subsidiary in the People’s Republic of China, Chasen Hi-Tech Machinery Services Pte Ltd, has secured a project to provide specialist relocation services for a flat-panel display manufacturing plant in Chuzhou, Anhui.

Chasen Holdings Wins S\$10.2 Million Relocation Contract in China

Singapore, 30 July 2018 – SGX Mainboard-listed Chasen Holdings Limited (“**Chasen**” or the “**Group**”), which offers turnkey relocation, third-party logistics as well as technical and engineering services, said today its subsidiary in the People’s Republic of China has secured a RMB51 million (S\$10.2 million) contract to help fit out a state-of-the-art flat panel display manufacturing plant in Chuzhou, Anhui Province.

Chasen Hi-Tech Machinery Services Pte Ltd, which is based on Chuzhou, will provide move-in, warehousing and related logistics services including rigging for the 8.6th Generation thin-film transistor liquid-crystal display (“**TFT LCD**”) manufacturing plant. The project will run for 16 months from September 2018 to December 2019.

Mr. Low Weng Fatt, Chasen’s Managing Director and CEO, said: ***“This is the first project Chasen Hi-Tech has secured in the same neighbourhood since it relocated to Chuzhou from Shanghai in 2017. Its ability to so quickly land a contract of this scale in Chuzhou reaffirms our established specialist relocation track record in China. We expect this project to contribute positively to our overall results for the current and subsequent financial years.”***

The project in Chuzhou comes just a month after the Group announced that all three of its business divisions had secured more than S\$38 million worth of contracts in total across Asia and in the US.
