Mr Chew Mun Yew has been re-elected as a Director of the Company at the AGM and will remain as the Chairman of the Remuneration Committee, a member of the Audit Committee and Nominating Committee respectively, and is considered to be independent for the purpose of Rule 704(8) of the Listing Manual of the SGX-ST. Mr Chew Mun Yew has also obtained the required approval in separate resolutions by (A) all Shareholders; and (B) Shareholders, excluding the directors, the chief executive officer and their associates, will continue his appointment as an Independent Director until the earlier of (a) his retirement or resignation; or (b) the conclusion of the third AGM of the Company.
 - b. Mr Chew Choy Seng has been re-elected as a Director of the Company at the AGM and will remain as the Chairman of the Audit Committee, a member of the Nominating Committee and Remuneration Committee respectively, and is considered to be independent for the purpose of Rule 704(8) of the Listing Manual of the SGX-ST.
